Covid-19 had a major impact on Little Hands Can. The lockdowns and quarantines of 2020 caused a pause in all of our programs for over a year. It was critical to help keep vulnerable people safe from the virus during times of uncertainty.

In 2021, operations resumed. A new board of directors was instated. The City Steward program, our core program, has been reinstated. This program reaches children of all ages and gives them the opportunity to serve in a variety of ways. Throughout the year, children and their caregivers have gathered to perform acts of service in the community. The majority of these activities have been held outside to help keep people safe. The children have enjoyed working in community gardens and park clean ups. We are working on increasing the number of activities and the variety of service partners.

We appreciate the support of our partner organizations and the families that work hard to bring back our programs.
